## ACADEMIC SENATE OF BAKERSFIELD COLLEGE CONSTITUTION AND BY-LAWS

# CONSTITUTION

# **ARTICLE I -- NAME**

- Section 1 The name of this organization shall be the Academic Senate of Bakersfield College, referred to herein as the Academic Senate.
- Section 2 The name of the legislative body shall be the Academic Senate of Bakersfield College, referred to herein as the Academic Senate.

# **ARTICLE II -- DEFINITION OF TERMS**

- Section 1 The Academic Senate refers to the organization comprised of all personnel designated under ARTICLE IV -- MEMBERSHIP of this constitution.
- Section 2 The Senate refers to all elected officers and elected Senators who represent the Academic Senate.
- Section 3 The College refers to the organization of all elements, and any combination of such elements, that compose the institution known as Bakersfield College.
- Section 4 A Discipline Area refers to any formal college department or grouping of departments which includes faculty (e.g. instructional/library/student support services)
- Section 5 A Senator refers to a person who is elected by a Discipline Area to serve on the Senate.
- Section 6 The Board of Trustees refers to the Kern Community College Board of Trustees and its official representatives.
- Section 7 The Board of Governors refers to the Board of Governors of the California Community Colleges and its official representatives.
- Section 8 ASCCC refers to the Academic Senate for California Community Colleges and its official representatives.

- Section 9 College-wide committees refer to those committees which involve faculty and other segments of the college, such as administration, classified staff, and students.
- Section 10 Faculty Caucus refers to a group of faculty members who are part of a collegewide committee.
- Section 11 Executive Board refers to the Executive Board of the Academic Senate.
- Section 12 Time-oriented references refer to working days.

### ARTICLE III -- PURPOSE

- Section 1 The purpose of the Academic Senate is to provide the means to represent faculty in the formation and implementation of policy on academic and professional matters.
- Section 2 In implementing policies, the Senate will represent the Senate to the President of the College and to the Board of Trustees with respect to academic and professional matters and exercise powers granted by the California Education Code and the Board of Governors.
- Section 3 The Senate shall assume primary responsibility in the areas of curriculum and academic standards as specified in the California Education Code.
- Section 4 The Senate shall maintain active membership in the ASCCC.

#### **ARTICLE IV – MEMBERSHIP**

- Section 1 All faculty not designated as management, confidential employees, or supervisors and employed by the College on fifty percent or more contracts whose current assignment places them on the Basic Faculty Salary Schedule shall be members of the Academic Senate.
- Section 2 Part-time, non-contract faculty members shall be associate members. Associate members do not have the rights and privileges of regular members, but they may elect a Senator as a voting member of the Academic Senate.

### ARTICLE V -- REPRESENTATION

Section 1 Each Discipline Area shall be represented on the Senate by one or more Senators, in accordance with ARTICLE IV of the BY-LAWS.

### Section 2 Nomination and Election of Senators

- a. Any nominee who receives a plurality of the votes cast shall be declared elected. In the event of a tie, a run-off between the two top candidates for Senator shall be held within two weeks of the original election.
- b. If there is no nominee for an office, that position shall remain vacant until the next regularly scheduled Academic Senate election.

#### Section 3 Terms of Office

- a. A Senator shall serve for a term of two consecutive years.
- b. One-half of the Senators shall be elected annually.
- c. If it becomes necessary to temporarily replace an Academic Senator, the Discipline Area may select his or her replacement subject to confirmation by the Senate. Failing either, the position will remain vacant until the next regularly scheduled election. The interim Senator would serve until the vacating Senator is able to resume his or her duties or until the next regularly scheduled election, whichever comes first.

A copy of this policy will be emailed to the vacating senator, the Discipline Area Chair, and the department secretary. The vacating senator or 2<sup>nd</sup> senator from the area and chair will work together to find a replacement, and the Discipline Area Chair will notify the Senate Office.

- d. Vacancies occurring at irregular times shall be filled by a special election within thirty days after the vacancy occurs, in accordance with the nomination and election procedures.
- e. When any Representative is incapable of performing the duties outlined below, the President shall conduct an election of that representative's Discipline Area according to the nomination and election rules to determine a successor.
- f. A vacancy that has been filled shall be filled for no longer than the original term of office.

Section 4 Reapportionment

The Senate shall evaluate its own structure prior to each annual election and, when appropriate, reapportion itself in accordance with ARTICLE IV of the BY-LAWS.

- Section 5 Responsibilities of Senators
  - a. A Senator shall attend all meetings of the Senate.
  - b. If a Senator misses three or more meetings of the Senate per year, she or he may be removed from office by a two-thirds vote of the Senate.
  - c. A Senator shall communicate business items and other concerns between her or his Discipline Area and the Senate.
- Section 6 Installation of Senators

At the conclusion of Old Business at the last Senate meeting of the academic year, the newly elected representatives shall be installed and shall conduct all New Business of the Senate.

### **ARTICLE VI -- OFFICERS**

Section 1	Officers
	The following shall be the officers of the Senate: President Vice-President Secretary Treasurer Delegate to the ASCCC
	Officers shall attend all Senate meetings.
Section 2	Parliamentarian
	A Parliamentarian may be appointed by the President.
Section 3	Nomination and Election of Officers
	a. Nomination and election procedures are defined in ARTICLE V of the BY-LAWS.
Section 4	Terms of Office for Officers

- a. The elected officers, with the exception of the President and the Delegate to the ASCCC, shall serve for one year.
- b. The President and the Delegate to the ASCCC shall serve for two consecutive years.
- Section 5 Duties of the President
  - a. The President shall preside over meetings of the Senate.
  - b. The President shall chair the Executive Board.
  - c. The President shall, with the approval of the Senate, appoint all members who serve on all committees that represent the Academic Senate.
  - d. The President may serve as an ex-officio member of all committees that represent the Academic Senate.
  - e. The President shall be the spokesperson for the Senate in all matters, but not at variance with Senate policy.
  - f. The President shall report the activities and the concerns of the Senate to the Board of Trustees on a regular basis.
  - g. The President shall act as the agent of the Senate for ordinary and ongoing business.
  - h. The President shall manage the Senate office and maintain posted office hours.
- Section 6 Duties of the Vice-President
  - a. The Vice-President shall assume the duties of the President when the President is incapacitated or absent.
  - b. The Vice-President shall act as Senate liaison with Discipline Area and/or Academic Senate committees, as directed by the President.
  - c. The Vice-President may serve as an ex-officio member of all committees that represent the Academic Senate.

Section 7 Duties of the Treasurer

a. The Treasurer shall be responsible for maintaining records of all income and expenditures of the Senate.

- The Treasurer shall make regular reports to the Senate. b. The Treasurer shall disburse funds at the direction of the Senate or its C. Executive Board. Section 8 Duties of the Secretary The Secretary shall publish the agenda for and the minutes of Senate a. meetings, reports of committees, and other appropriate documents. b. The Secretary shall report communications to the Senate and initiate correspondence as directed by the Senate. The Secretary shall maintain a list of Discipline Areas, including names C. and numbers within each Discipline Area. The Secretary shall maintain a list of all Academic Senate members. d. Section 9 Duties of the Delegate to the ASCCC a. The Delegate to the ASCCC shall attend ASCCC meetings.
  - b. The Delegate to the ASCCC shall report the proceedings of the fall and spring state meetings to the Senate and, if requested by the President, to the Board of Trustees.
  - c. The Delegate to the ASCCC shall chair the Government Affairs Committee.
  - d. The Delegate to the ASCCC shall communicate statewide legislation and other concerns to the Senate.
- Section 10 Installation of Officers

At the conclusion of Old Business at the last Senate meeting of the academic year, the newly elected officers shall be installed and shall conduct all New Business of the Senate.

### ARTICLE VII -- REFERENDUM

Section 1 Upon presentation to the Senate of a referendum petition, signed by fifteen percent of the Academic Senate members protesting an action by the Senate, the President shall suspend such action until a referendum election is held.

Section 2 Within three weeks, excluding recesses and holidays of the suspension action, an election shall be conducted. If a majority of Academic Senate members vote against the Senate action, then the Senate action shall be null and void.

### ARTICLE VIII -- RECALL

- Section 1 If a recall petition asking for the recall of any officer, signed by fifteen percent of the Academic Senate membership, is presented to the Senate, a recall election shall be held.
- Section 2 If a recall petition asking for the recall of any elected Representative, signed by twenty-five percent of the membership in the area of representation, is presented to the President, a recall election among the members of the Discipline Area shall be held.
- Section 3 All recall elections shall be held within three weeks, excluding recesses and holidays, of receipt of the recall petition.
- Section 4 An officer shall be recalled if at least fifty percent of the Academic Senate cast a ballot and a majority of votes are in favor of recall.
- Section 5 A Senator shall be recalled if at least fifty percent of the Discipline Area cast a ballot and a majority of votes are in favor of recall.

### **ARTICLE IX -- RATIFICATION**

- Section 1 This Constitution shall be ratified by a two-thirds affirmative vote of the ballots cast by the members of the Senate Association. Ratification of this Constitution shall require a two-thirds affirmative vote of the membership voting and, additionally, shall be ratified only if at least fifty percent of the Senate Association members cast ballots.
- Section 2 Voting shall be conducted by official ballot.
- Section 3 Ratification of this Constitution shall revoke any and all previous Constitutions of the Academic Senate and/or the Senate.

### ARTICLE X -- AMENDMENTS

Section 1 Amendments to this Constitution may be proposed to the Senate which, upon a two-thirds affirmative vote, shall submit the proposed amendment to the Academic Senate for a ratification vote.

- Section 2 Amendments to this Constitution shall also be placed before the Academic Senate for a ratification vote if a proposed amendment is submitted to the Senate endorsed with the signatures of fifteen percent of the membership of the Academic Senate.
- Section 3 Ratification of a proposed Constitutional amendment shall require a two-thirds affirmative vote of the membership voting and, additionally, shall be ratified only if at least fifty percent of the Academic Senate members cast ballots.

## **BY-LAWS**

### ARTICLE I -- ESTABLISHMENT OF QUORUM

- Section 1 A quorum for meetings of the Academic Senate shall consist of twenty percent of the membership.
- Section 2 A quorum for meetings of the Senate shall consist of fifty percent of the Officers and Senators.

### **ARTICLE II -- GENERAL MEETINGS**

- Section 1 General meetings of the Academic Senate may be called by the President, with approval of the Senate, whenever they are deemed necessary.
- Section 2 General meetings of the Academic Senate may be called either (1) upon the written request of twenty percent of the membership of the Academic Senate or (2) upon the written request of any three members of the Executive Board of the Academic Senate.

### ARTICLE III -- DUES AND DONATIONS

- Section 1 The Senate shall determine the amount of dues.
- Section 2 Payment of dues is not a necessary requirement for membership.
- Section 3 Dues may be collected from the members of the Academic Senate by the Treasurer on an annual basis to meet the ongoing needs of the Academic Senate and special donations may be solicited to meet unusual financial responsibilities.

Section 4	Donations to the Scholarship Fund of the Senate shall be accepted by the Treasurer and shall be reported to the Senate in the Treasurer's Report.

Section 1	The Senate shall consist of the elected officers and Senators.

Section 3	Senators have the right to identify a voting proxy in their absence. The Voting Proxy Form is required.			
Section 4	Any Academic Senate member eligible to vote in a Discipline Area Chair election shall be considered a member of that Discipline Area for purposes of apportionment and reapportionment. A Discipline Area member with less than a fifty percent assignment will be counted as one-half in that Discipline Area.			
Section 5	Apportionment			
	a. Each Discipline Area of the college shall be entitled to at least one elected Senator.			
	b. A second Senator shall be elected provided that a Discipline Area contains sixteen (16) or more members of the Academic Senate.			
	c. A third Senator shall be elected provided that a Discipline Area contains thirty-one (31) or more members of the Academic Senate.			

d. If more than one Senator is elected from a multi-discipline area, it is the intention of this document that the Senators be elected, if possible, from different disciplines within the Discipline Area.

#### Section 6 Reapportionment

- a. The Academic Senate shall include members on sabbatical and on a one or two semester leave.
- b. Each spring semester, and by April 1, the Senate shall examine its membership structure.
- c. A Discipline Area with fifteen (15) or fewer members shall be allowed only one representative.
- d. If a Discipline Area has two seated representatives and its membership drops below sixteen (16) its seated representatives will be allowed to serve their terms and, when either or both terms are completed, it will be reduced to one representative.
- e. If a Discipline Area has three seated representatives and its membership drops below thirty-one (31), its seated representatives will be allowed to serve their terms, and, when either or both terms are completed, it will be reduced to two representatives.
- f. If a Discipline Area has grown to thirty-one (31) or more members, an additional representative shall be allowed at the next regularly scheduled election.
- g. If the size of any Discipline Area is disputed, the dispute shall be settled by the President of the Senate after consultation with the Faculty Chair to verify the Discipline Area membership.

### ARTICLE V -- NOMINATION AND ELECTION PROCEDURES

- Section 1 Officers shall be nominated and elected-at-large.
- Section 2 Nomination of Senators
  - a. Senators shall be nominated and elected by Discipline Area.
  - b. A master list of Discipline Areas, including the names and numbers of members in each Discipline Area, is to be maintained by the Secretary and posted in the Senate office.

- 4. An Academic Senate member on a one or two-semester paid leave is entitled to vote based upon the normal area of assignment.
- To be eligible to vote in Senate-conducted elections, Academic Senate members, in addition to meeting the requirements of Article IV of the constitution, must be tenured, in a tenure-track position, or in at least the third consecutive year of temporary contract employment.
- e. If no nominee receives a majority of the votes cast, a run-off election shall be conducted between the two candidates receiving the most votes.
- f. If there is a tie vote in a Senate or Discipline Area election, and the Discipline Area is unable to reconcile the matter within thirty days, the winner shall be determined by a toss of a coin at a regularly scheduled Senate meeting.
- g. The results of all elections shall be announced at the next Senate meeting. The results will be included in the Senate minutes and forwarded to the College President.
- h. The vote count will be available in the Senate office after each election.
- Section 7 The Senate, by a two-thirds majority vote, may substitute special election procedures if circumstances not anticipated by ARTICLE V should occur.

## **ARTICLE VI -- EXECUTIVE BOARD**

- Section 1 The Executive Board of the Academic Senate shall be comprised of the following:
  - President Vice-President Secretary Treasurer Delegate to the ASCCC Immediate Past President (Ex-officio)

## New Faculty Orientation Committee Equivalency Committee

Section 6 Government Affairs Committee The Government Affairs Committee shall consist of three or more Academic Senate members and shall be chaired by the Delegate to the ASCCC. This committee shall monitor local, state, and federal legislative activity, including related regulatory agencies, in order to inform the Senate of the legislative and regulatory environment. Section 7 New Faculty Orientation Committee The New Faculty Orientation Committee shall consist of three or more Academic Senate members. This committee will plan a Senate welcome and orientation for new faculty members and will assist in college-wide planning and training related to new faculty. Section 8 6 Equivalency Committee The Academic Senate Equivalency Committee is responsible for determining if an applicant's qualifications are the equivalent of the Minimum Qualifications for Faculty in California Community Colleges. Section 9 7 **College-wide Committees** College-wide committees must be approved by the Senate before any faculty appointees are confirmed. The composition and duties of college-wide committees are normally found in the Section 10 8 Bakersfield College Policy and Procedures Manual. The Senate shall review and update this listing of college-wide committees on a periodic basis. - Section 11 9 The Senate President may designate the leader of a faculty caucus for any college-wide committee.
- Section 12 10 Ad Hoc Committees

Ad Hoc Committees of a temporary nature may be approved by the Senate at any time.

- Section 13 11 All Senate appointees to all committees shall receive in writing the composition and duties of said committee, as approved by the Senate. In addition, appointees shall seek advice from the Senate before acting on new, substantive policy decisions.
- Section 14 12 Committee reports may be scheduled ahead of New Business or Old Business at any Senate meeting.
- Section 15 13 If the Senate votes to discontinue its involvement in any committee, then the Senate appointees to said committee shall be immediately notified that their appointments are thereby revoked.

### **ARTICLE VIII -- LIMITATION ON PUBLIC STATEMENTS**

- Section 1 The President shall be the official spokesperson for the Senate.
- Section 2 The President shall not take a position on public issues unless one of the following conditions is met:
  - a. The position of the Senate is already a matter of record.
  - b. The President is given specific authorization by the Senate to express an opinion on a given public issue.

c. The issue is submitted to the Academic Senate and, the Academic Senate authorizes the President to issue an opinion on a given public issue.

#### **ARTICLE IX -- COLLECTIVE BARGAINING AGENT RELATIONSHIP**

- Section 1 The Senate shall cooperate with the collective bargaining unit, within the scope allowed by the California Education Code, the Board of Governors, and any other legal statutes.
- Section 2 The Senate, at appropriate times, shall invite a representative of the collective bargaining unit to Senate meetings to share matters of mutual concern.

### ARTICLE X -- AMENDMENTS TO THE BY-LAWS

- Section 1 Amendments to these By-Laws may be proposed by the Executive Board, by any three Representatives, or by petition signed by ten percent of the Academic Senate
- Section 2 Amendments to these By-Laws shall be ratified by a two-thirds vote of the Senate members, present and voting.
