Multiple senators shared comments. EODAC Co-Chairs shared comments.

A motion was made to include comments on the floor from E-Board Co-Chairs.

Senator W. Ellis moved to approve the E-Board members to comment, Senator M. Hart seconded; motion passed unanimously.

Multiple E-Board members shared comments.

President S. Holmes responded to questions regarding the BC Student Equity Plan. The 2019-22 summary presented to the Senate in early Spring was not the final document. The Senate

approved the summary in order to meet the mandated timeline. This plan is not a campus-wide plan and does not include professional development and is not comprehensive.

Senator A. Bolar moved to approve the BC AS Resolution, Senator O. Garcia seconded; motion rescinded.

Discussion:

Multiple senators shared comments, including a request to table the matter so further discuss could take place within departments; following the comments the motion was rescinded, approved by $1^{st}/2^{nd}$.

Senator P. Parks moved to support the EODAC Equity Commitment v9, Senator M. Zikri seconded; friendly amendment: to remove Latinx and replace with Hispanic/Latino/a/x; motion passed

Discussion:

Multiple senators shared comments.

Multiple Senator requested item be tabled. C. Newton moved to table for further discussion within departments, amendment rejected by 1st/2nd.

Secretary M. Garrett moved #1 to make a friendly amendment to replace "Latinx" with Latin/Hispanic; #2 to remove "hiring practices" from commitment 3; #3 to remove "environmental microaggressions, implicit bias, and". Amendment #1 accepted by 1st/2nd; Amendments #2 and #3 rejected by 1st/2nd.

Senator W. Ellis moved to make a friendly amendment: The paragraph talking about future work on a comprehensive equity plan could be inserted either at the beginning in the preamble or at the end after the commitments. It might look like the end of the E-Board resolution: Bakersfield College will build upon these actions by engaging in an in-depth and thorough process that develops a Comprehensive College Equity Plan designed for outcomes instead of compliance—an Equity Plan that ensures all students and employees are able to fulfill their potential regardless of gender, race, ethnicity, class, religion, disability, sexuality, or other identity. The Bakersfield College Equal Opportunity and Diversity Advisory Committee will guide the effort of a cross-college team to comprehensively address equity and racism. This cross-college team will report at least quarterly to the Academic Senate and rely upon faculty and student representatives from all pathways and affinity groups including research, human resources, technology, support services, classified staff, and possibly community members as necessary. Amendment rejected by 1st/2nd

Senator M. Zikri called for the question.
