B. <u>Credit for Prior Learning</u> (Nickell) – 2<sup>nd</sup> READ

Description: Credit for Prior Learning (CPL) is college credit awarded for validated college-level skills and knowledge gained outside of a college classroom.

J. Johnson presented the draft procedure on behalf of the workgroup as stated in BP 4C1. #### **NEW BUSINESS**

A. BC GE Pattern Guidelines (Menchaca)- INFO

Description: The GE sub team of the Curriculum Committee requested the guidelines be clarified to match how the BC GE pattern is presented in the catalog. The only change to the BC GE pattern itself is the explicit separation of category E into E.1 and E.2. The separation was implied in the catalog prior to this change.

Co-Chair Menchaca informed the group that there are two components, one is health & wellness and the other is physical activity. This will be a clarification in the upcoming catalog.

President S. Holmes announced that this is a non-voting item and for informational item for Senators to share with their constituents.

### B. Competency Based Ed (Menchaca)- 1st READ

Description: Competency Based Education Implementation (CBEIM) is an ad hoc committee that will coordinate implementation, program development, and monitor progress in accordance with the guidelines for the CCCCO Collaborative.

J. Wojtysiak took the lead to present and share the following highlights of the committee's tasks:

- Develop a planning/implementation timeline;
- Communicate progress within the chancellor's CBE Collaborate Pilot;
- Solicit input from internal and external stakeholders;
- Oversee project development and implementation;
- Support, engage, and coordinate faculty in the development of start-up processes and materials;
- Disseminate information to faculty and staff campus-wide;
- Coordinate professional development

The committee is applying for a CBE Collaboration in which ten colleges will be selected to pilot.

J. Johnson, E. Menchaca, C. Dison, and L. Elliot (BC student) contributed to the presentation.

This item will move to UB as a  $2^{nd}$  READ for 2/17/21. This will be a voting item on whether to participate or support the pilot program.

## C. CSU GE Area F Requirements (Osea)- INFO

Description: New CSU GE Area F requirement & its impact on CSU GE Area D.

Co-Chair M. Osea presented information on the CSU Chancellor's office new executive order for guiding the CSU general education breadth requirements. These can be found on the website:

https://calstate.policystat.com/policy/8919100/latest/. The change will be six semester lower division units and three additional upper division units to be completed. Variations of this language will be appearing on the new CSU breath pattern. The students that were required to take two courses in the same discipline, now have an option.
