Review and monitor collection of evidence and progress on actionable improvement plans, accreditation recommendations, and institutional effectiveness indicators.</li> <li>3. Inform, engage, and involve the college community in accreditation and institutional effectiveness.</li> <li>4. Review and monitor evaluation activities to ensure they result in integrated, meaningful, and sustained college improvement.</li> </ol>
