ISIT Committee Feedback

ISIT Committee Meeting of 10/13/2025 - Highlights

Attendance: 19

The committee shared that the inconsistency of leadership impaired their progress. The committee wanted guidance and constructive criticism, but this was not provided.

The committee is concerned with the change of membership to pathways. Individual departments would not have a voice, and the pathway rep would focus on their requests.

Revising and rebranding the charge would make sense, since the same members will want to serve.

The committee is more than willing to do the work but is lacking direction.

The committee wants to work with the Administration and does not want technology projects on hold because of them and wants what's best for the committee to move forward.

The ISIT Director has always been the default Admin Chair, and concern was raised as to why this is no longer the case.

The committee's Faculty Chair reassigned time was removed; however, it could be reconsidered.

Meetings via zoom may have contributed to the lack of attendance.

Motion was made and approved to change meeting modality to hybrid. Majority to meet in L160, on the 2nd Monday from 4-5 (same day/time).

 - ISIT was tasked by the Senate to research and make a recommendation for AI software suggestions. The committee created a workgroup who completed the task. The Academic Integrity and Online Classes Recommendation from ISIT submitted to the Senate and VPI office on 4/30/2025 but didn't receive feedback.

- Program Review Summary Report for 2024-25 – ISIT received 42 tech requests and 11 other requests to evaluate. The previous ranking from ISIT was reported by Admin that only 4 members were present; this is inaccurate according to the PRC Chairs and the ISIT members.
- Annul ISIT technology survey – on hold pending chair vacancy.
- BC Technology Plan – on hold pending chair vacancy.
- PRC technology resources have been submitted for review 10/14/2025 - TBD pending chair vacancy (Senate President is current Chairing the ISIT committee.

Many of the tasks are on hold due to lack of committee leadership.

Executive Board Feedback to ISIT/TICC Proposal

Consensus of the E-Board:

- To revise and rebrand the current committee as the past practice and best course of action.
- The process of dissolving a committee and creating a new one is a longer process and will not be in effect until next Fall, which will impede the faculty's voice for scheduled technology projects.
- For the balance of the faculty membership to remain the same since the TICC proposal has a limited presence of faculty.
- To request feedback from the ISIT committee members so this can be considered.
