5. The Kern CCD Board of Trustees approves a timeframe spanning Week 9 to Week 12 of the Spring semester, or ending the Saturday prior to Easter, whichever is greater, in which colleges may select a one-week period for Spring Recess from Monday through Saturday of the same week, including an operational closure on Friday as a Classified, Confidential & Management Holiday.
