Optional Bio: Dear Academic Senate,

I would like to be on the screening committee for the next vice president of instruction.

I have been a faculty member at Bakersfield College since the fall of 2005, teaching in the Industrial Technology department. Before that, I taught for ten years at South High School in Bakersfield, California. I have a bachelor's degree in industrial arts and a teaching credential from Fresno State and a master's degree in educational leadership from Point Loma Nazarene University.

I have worked my entire career with students of varying ability, gender, national origin, race, religion, sexuality, and socioeconomic status. South High School was over 75% Hispanic when I taught there and currently has minority enrollment of over 95% of the students. Bakersfield College currently has a Hispanic population of approximately 70% and the total minority population is over 80% of enrollment.

Through the years, I have taught classes in construction, industrial drawing, industrial technology, and woodworking. I have served as the department chair for Industrial Technology for over six years, and I manage programs at several locations, including the BC main campus, Delano, BCSW, prison, and high school locations. I have served on various committees, including the Academic Senate and Program Review. I am the current representative to the academic senate for Industrial Technology.

I believe it is important to have a representative from CTE on the screening committee.
