As we start the new year, I want to remind everyone that we have a shared responsibility to help prevent the spread of COVID-19. The individual shares a significant burden of this responsibility to our collective public health and safety, and we all have an obligation to hold ourselves personally accountable for following the proper guidelines to protect our campus and our families.

Currently, BC is only open for *essential courses only*, meaning select courses in the Public Safety or Health Sciences pathways, courses that lead to employment in critical areas such as construction or HVAC, courses at the end of a certificate or degree path that are not offered frequently, or courses with Student Learning Outcomes that *absolutely* cannot be met through a virtual environment. Over the summer, we've developed a process to determine face-to-face needs and ensure that health and safety protocols are in place for essential activities. COVID-19 Updates

Governor Newsom's daily addresses over the last week have been primarily focused on the <u>wildfires that are raging across California</u>, but he continues to provide updates on the state's COVID-19 response. On Monday's broadcast, he announced that the state will be releasing new guidelines later this week for counties that have been taken off the state's monitoring list. Kern County is still firmly on the monitoring list for California, as the data points below will indicate.
