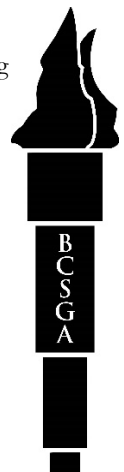
Chair Limaco opened for discussions about concerns requiring legislation pertaining to the Committee
