
4. PUBLIC COMMENT

Adviser Ayala: We cannot independently hire a contractor based on your bylaws. You can write a resolution for this because we govern the student body.. Campus marketing has a lot of hands in the cookie jar because this is the image of campus. President Miranda: We have power to push this to Dr. Fliger but more quantity is best, these resolutions seem like we're writing on paper but they aren't because it goes to the President's Office. If you say "here's our plan, here's what we need; Give us money", then he might approve it.

Adviser Ayala: They are going to a campus rebranding so it might be a good time to do it or it might be a bad time.
