

The Senate may consider the character, professional competence, physical or mental health, or other matters permissible under the Brown Act during consideration of this item. Then, the Senate will consider a binding resolution to appoint a Senator as the Senate Officer established by the BCGSA COBRA. Under the Brown Act, the meeting may not be closed.*

- a. Appointment of Mr. Samuel Handy for the position of BCSGA Director of Finance
  - President Mackey: believes Handy is an excellent advocate for students on campus; understands numbers and finances of students at BC campus
  - Sam Handy: introduction, has strong presence on campus
  - Senate questions
    - o Senator West: background in finance?
      - Handy: none, but is a math tutor, takes personal finances seriously
    - o Senator Ramirez: plan on how to manage budget?
      - Handy: None at moment but plans to; doing what is good for the people
      - Ramirez: Interested in doing more than finance?
      - Handy: would like to be involved where helpful; awareness of sticker program; advice from former Director of Finance
  - Floor questions
    - o Director Griepsma: Why choose finance position?
      - Handy: Had insight from former director and fit interests.
      - Griepsma: What are strengths in relation to position?
      - Handy: Communication, especially with money, wants to make everything understandable
      - Griepsma: How to promote KVC stickers?
      - Handy: unsure of limits and restrictions of promoting sticker, interested in brainstorming and advocacy through counseling center; applying principles from tur
    - o Danielle: Any experience outside of BC?
      - Handy: Worked for solar and construction company; interim design team lead
  - Pros and Cons debate from the Senate:
    - o Pros: admired work ethic and would be suitable
    - o Pros: motivation
    - o Cons: ability to split time properly between BCSGA Finance role and outside duties
    - o Pros: eager
    - o Cons: no background in Finance
  - 4/4 Ayes; members in agreement with appointment of Sam Handy to Director of Finance
- b. Appointment of Ms. Sara Pogue for the position of BCSGA Director of Public Relations
  - President Mackey: has confidence in Pogue since she has done roll already and is well loved by peers, great work ethic
  - Pogue: introduction; previously worked with Lavendar initiatives and as Senator with BCSGA before being appointed to first term of PR role
  - Senate Questions:
    - o Senator Ramirez: Do you love your role in BCSGA?
      - Pogue: Yes, role solidified interest in marketing career
    - o Senator West: What do you classify as something well made for the role of PR?
      - Pogue: believes content must hit different points and demographics
  - Pros and Cons debate from Senate:
    - o Pros: nice background and eagerness
    - o Pros: solid previous work
  - 4/4 Ayes; members in agreement with appointment of Sara Pogue to Director of Public Relations
- c. Appointment of Ms. Danielle Nicole Baker for the position of BCSGA Director of Student Activities
  - President Mackey: narrowed down what position Danielle was fit for, very complex and understands many things, was passionate about student activities

- Baker: was interested in Student Activities or Finance role; had experience in humanitarian roles and volunteer experience; has a focus in helping others and team building
- Senator Questions:
  - o Senator Ramirez: What narrowed down decision for student activities role?
    - Baker: the big picture and what could do in short term; enjoyed attending student activities
    - Senator Ramirez: events in mind?
    - Baker: football games; emerging events and subjects that haven't been present for a while
- Floor Questions:
  - o Director Griepsma: Activities in mind that you want to implement other than sports?
    - Baker: promoting reading and learning, education, creativity
- Pros and Cons debate from Senators:
  - o Pros: previous experience
  - o Pros: eagerness to work
  - o Cons: potential ideas but wondering which will help
- 4/4 Ayes; members in agreement with appointment of Danielle Nicole Baker to Director of Student Activities
- d. Appointment of Mr. Javier Alvarez Cortes for the position of BCSGA Director of Legislative Affairs
  - President Mackey: believes Cortes is well organized and a leader; is able to learn and teach
  - Cortes: no experience with SGA, works with NAASSP
  - Senate Questions:
    - o Senator Ramirez: Will you be able to understand the role of legislative affairs?
      - Cortes: Believes will get hang of role, has experience with helping people understand tribal recognition and ancestry
      - Ramirez: How to properly advocate for college students?
      - Cortes: believes proposed legislation should affect all people and recognizes different backgrounds
    - o Senator Velasco: Why are you a good addition for the role of legislative affairs?
      - Cortes: has current understanding of how laws affect people
      - Velasco: What is your major and are you familiar with the legal system?
      - Cortes: believes teachers should be knowledgeable with forms of government, so is familiar with such things
  - Floor Questions:
    - o Director Pogue: Are you aware of the conference SSCCC?
      - Cortes: no but is willing to attend conference meetings
    - o Director Griepsma: Are you willing to help with change outside of current programs?
      - Cortes: goal is to advocate for everyone and recognize all demographic groups
      - Griepsma: Are you willing to discuss hard-hitting topics and questions?
      - Cortes: yes
    - o President Mackey: Have been in situation where you didn't feel qualified, but you overcame that?
      - Cortes: seasonal position role
  - Pros and Cons debate from Senators:
    - o Motion to move voting until next meeting by Senator Velasco, seconded by Senator Ramirez
    - o Motion approved and item tabled until next meeting
- e. Appointment of Mr. Oscar "Ozzy" Hernandez for the position of BCSGA Parliamentarian
  - Item skipped

## 9. ELECTION OF OFFICERS OF THE SENATE

*The Senate may elect a Senate Pro-Tempore, pursuant to the BCSGA Constitution Article VI, section 6, and Chairperson of each Senate Standing Committee. The Senate may consider the character, professional competence, physical or mental health, or other matters permissible, of certain individuals during consideration of this position. Then, the Senate will consider a binding resolution to appoint a senator as the Senate Officer established by the BCSGA Cobra. Under the Brown Act, the Senate may not close the meeting.*

- a. Election for Senate Pro-Tempore
  - Senator West nominates Senator Velasco
  - Senator Velasco: believes in control of conversation and able to call out decisions, and has good moral standing
  - Pros: most malleable person of current senate
  - Pros: positive demeanor
- b. Election of Chairperson to the Senate Committee on Academic Affairs
  - 3/3 Ayes from senators, motion carries to approve Senator Velasco to be Pro-Tempore

## 10. APPOINTMENT OF SENATORS TO COMMITTEES AND DEPARTMENTS

*The Senate will recommend members to each of the Senate Standing Committees and the BCSGA Departments. Under the Brown Act, the Senate may not close the meeting.*
