 - o Advisor Cordova: not an official discord that is monitored through OSL or SGA, uses Microsoft Teams so there is no anonymity

 - o Senator Ramirez: How will you ensure your advising opinions are neutral?
 - Hernandez: intends to treat people how they treat everyone else; maintain professionalism and respect
 - o Senator Perez: Do you have experience reading and interpreting SGA documents? Any experience doing so?
 - Hernandez: helped run and coordinate the Choir departments events in high school; ICC for club on campus
 - o Senator West: Why is there a gap in education while attending BC?
 - Hernandez: resume typo
 - Senator West: Was there reason to not write a concise letter of intent?
 - Hernandez: wanted to show who they were, wants to treat issues with unbiased opinions
 - o Senator Ramirez: You have experience with tracking, but how does it relate to SGA documents?
 - Hernandez: studied for position and student rights at BC and for club
 - Senator Ramirez: Do you plan on working towards the goals of students and not your own personal goals?

- Hernandez: yes
 - Floor questions:
 - Director Baker: What skills are you bringing to the table for this position?
 - Hernandez: open communication, equality, freeness of speech; wants to give info for people who miss meetings
 - Director Baker: What are other people's perspectives on your work ethic?
 - Hernandez: looks at feedback and works to make improvements
 - Pros and Cons from Senate:
 - Pro, Senator Velasco: believes candidate is eager
 - Con, Senator Velasco: hopes opinions will not be biased if elected for position
 - Pro, Senator Ramirez: believes candidate is caring for students
 - Con, Senator Ramirez: sees no vision for this role; lack of experience; lack of understanding of role
 - Pro, Senator West: motivated and well intent
 - Con, Senator West: resume and letter of intent are lacking
 - Pro, Senator Perez: eager and determined for position
 - Con, Senator Perez : shaky idea for position; wrong idea for Parliamentarian, more senator
 - Motion by Senator West to table agenda item until next meeting for further consideration or for candidate to apply for senator position, Seconded by Senator Velasco

 - Review of Resume and Letter of Intent

 - Senator Velasco: How will you ensure transparency with allocating student org funds?

 - Senator Ramirez: What strategies do you have to explain the process of allocating funds to clubs?
 - Perez: willing to make self available for people with such concerns
 - Senator Ramirez: Are you willing to say no to clubs who do not meet criteria for funds?
 - Perez: Yes, is willing to do so
 - Director Griepsma: SOF manager is limited in operating and extending money grants; certain steps to go through to approve funds
 - Pros and Cons from Senate
