- Questions from Senate:
 - Senator Velasco: What do you believe are the duties of a senator?
 - L. Hernandez: To use power that comes from the role of the senator because they are the voice of the people.
 - o Senator West: Do you have any specific resolutions in mind?
 - L. Hernandez: None at the moment.
 - O Senator Ramirez: How do you plan to use performer role with senator duties?
 - L. Hernandez: Use those skills that come with each role for people who are unable to do so
 - O West: Are you able to recognize the senator's role in representing people that are not just out of high school?
 - L. Hernandez: Recognizes ability to represent people from all walks of life, believes college students aren't just here to learn but to network and find open doors

 - Director Griepsma: What goals do you have to make changes happen on campus?
 - L. Hernandez: Men's mental health awareness
 - Griepsma: What programs to push to support mental health?
 - Hernandez: Therapy programs
 - Griepsma: What changes do your peers want to see?
 - Hernandez: More pantry selection
- Senate Pros and Cons debate:
 - O Pros: believes nominee is very eager and brings energy into the senate
 - O Cons: does not have a true vision on what the duties of the senator are
 - O Cons: ability to not let one event overshadow another
- Roll call vote: 2/3 motion is carried to the election of L. Hernandez
- b. Election of Mr. Elijah Hernandez for the position of BCSGA Senator at-Large
 - Review of letter of intent and resume
 - Self-introduction
 - Questions from senate:
 - O Senator Velasco: What are some issues on campus?
 - E. Hernandez: Lack of representation for dual and concurrent enrollment students; wants creation of new committee for these students
 - Senator West: Will being a concurrent enrollment student affect responsibility as senator?
 - E. Hernandez: No, can balance time
 - Senator Ramirez: How did you hear about the senator position?
 - E. Hernandez: Originally applied for student activities manager, was recommended to senator position
 - O Are you aware of committee meetings?
 - E. Hernandez: Yes, and committed to going to those meetings
 - Floor questions:
 - Trustee Miranda: What is the reason for switching to senator position?
 - E. Hernandez: Was recommended for position and was not able to uphold requirements for student activities position
 - Director Griepsma: prepared to stand ground in tough meetings with faculty?
 - E. Hernandez: Yes, is willing to stand ground with proposed ideas
 - Senate Pros and Cons:
 - O Pros: solid idea for concurrent committee, has good ideas
 - O Cons: time management
 - O Pros: provide representation for concurrent and dual enrollment members; able to verbalize commitment to meetings

 - Perez: Co-founder of student outreach and advocacy club; would talk with students of concern every other week and work with them through their problems or concerns
 - O Senator West: Do you take most of classes on main campus?
 - Perez: Majority yes, next semester with one at southwest campus
 - West: Plans for satellite campus unification; using Instagram to unify?
 - Perez: Two separate problems; opportunity to remind vendors about other events on campus; ensure access of main campus resources to satellite campuses
 - Senator Ramirez: What does this community look like to you?
 - O Great community; lots of inclusivity; civil engagement
 - Floor questions:
 - O Director Griepsma: In letter of intent, you wanted to see changes happen on campus. What are those changes?
 - Perez: People having access to resources; mostly awareness of scholarships and financial opportunities
 - Griepsma: How do you intend to stay connected with students across all campuses?
 - Perez: Events held at other campus; possibility of committees at each campus for events
 - o Director Baker: What is your 5-year plan and its relatability to BCSGA?
 - Perez: is a history and political science major, would like to pursue law
 - Baker: How did you get involved specifically and how did you start SOAR program?
 - Perez: SOAR done in conjunction with advisor for organization
 - Pros and Cons:
 - Pros: admires how he represented students before this position
 - o Pros: has strong resume
 - o Pros: has a strong attitude and willingness to serve
 - Roll call: 3/3 motion carried for the election of Perez
