- Questions from Senate floor:
  - Senator Garcia: With your current responsibilities, are you well equipped with skills to manage your time wisely and support the Student Organizations Department?
    - Dirden: yes, feels equipped for it; First Renegades meetings will not conflict with SGA meetings
  - Senator Jawad: will you be willing to give equal funding to each organization?
    - Dirden: yes, wants to be an ally for each club
    - Director Griepsma: SOF Grant manager cannot give favoritism to clubs by law
- Pros and Cons debate from Senate:
  - o Pro, Senator Jawad: great resume, believes will do well in position
  - Pro, Senator Perez: sees valuable experience in already being an ICC Rep for a club
- Roll call vote: 4/4 members vote in favor of the election of Frankie Dirden to Student Organizations Funding Manager

      - Serna: lots of skill and responsibility that comes from being in a leadership role; see it as an opportunity to push self
    - Senator Perez: Any ideas for resolutions?
      - Serna: gap between administration and the students; more advocacy for students having a voice in decisions on campus, get more students involved
  - Pros and Cons debate from Senate:
    - Pro, Senator Jawad: saw LOI and Resume as great and believes will be great fit for a senator
    - O Pro, Senator Perez: big heart for applying self and sees value in having the students heard on campus
  - Roll call vote: 4/4 members vote in favor of the election of Emiliano Serna for the position of BCSGA Senator at-Large

Vice President Moore: last meeting was held on October 1<sup>st</sup>; Student Equity Plan 3.0 was presented by Vice President Dr. Jimenez; visiting admin officials expressed concerns over what they view as "atrocious" distance learning (online) classes at Bakersfield College; Vice President of Instruction has transferred funds from her own budget towards STEM programs

Director Griepsma: new catalog update for the academic year 2026-2027, catalog will change from Summer to Summer to Fall to Summer, expected to help students planning to transfer and students receiving financial aid; the following items were passed at the committee: Charge Gold, Business Education, Correspondence Education, General Education; CRIM BIO P10 rejected on GE and CalGETC because of error

g. Equal Opportunity & Diversity Advisory Council (EODAC)

Senator Perez: EODAC concerned that students no longer have a rep within the Professional Development Committee, were hoping to get a person from EODAC

to sit on that committee; EODAC wants to make sure HR is conducting a DEIA

screening of incoming faculty or of people who professors and instructors are hiring at Bakersfield College

Senator Jawad: reason for screenings was that it was found not a lot of diversity was found within each department

h. Enrollment Committee

Agenda item skipped, no committee member present.

i. Facilities & Sustainability Committee

Senator Perez: greenhouse is now being used at the new Agricultural Sciences building; parking lot expansions; Parking lot 8 solar power energy not being fully utilized as of now; Student Housing will open in Fall of 2026

Senator Garcia: 623 work orders in 2024, 599 this year; decrease in work orders due to HVAC workers limitations, now two people doing work orders; Fine Arts has had significantly more work orders than last year; next meeting November 5<sup>th</sup>

- Information Services & Instructional Technology (ISIT) Senator West: was unable to make it to last meeting but will attend the next one on Monday
