Advisor Cordova- wants to push to ideas to lobby for change and maybe more restrictions on petitioners, even though they are entitled to their first amendment rights. Protocol is in place for petitioners however it is not mandatory at this time. College safety is an option if students feel like they are being harassed or are being detained by petitioners.

Senator Lara- maybe implementing a badge system to give petitioners

Senator Perez – asking for clarification

President Mackey- the badge needs to be identifiable and distinct to BCSGA badges

Director G- petitioners are not likely to return and leave badge , another concern is that the petitioners may hold on to badges and bypass the sign in in future days.

Adv. C- looking at other campus is a good place to start and come up with ideas on how we can control the petitioners without violating anyone's rights. A focus on safety for our students the best way of looking at the issue with the petitioners
