5. REPORTS OF THE ASSOCIATION

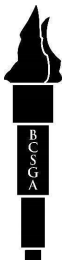

- c. DISCUSSION: Strategic Planning Student Representatives committee that will be working on things such as landscaping and physical aspects of the colleges including bakersfield college, cerro coso and porterville

DISCUSSION: Debrief on Welcome Week the inclusion of tents at southwest campus was greatly appreciated and the ice cream social was a great success, issues on coffee supplies was discussed and have been passed along, discussed issues with other events such as tents being left alone and students struggling to access the resources that was supposed to be provided by the welcome tents also courtesy of clean up of the supplies from workers was not provided, messes that occurred with paint n sip in the dining commons such as water on the floor and paint clean up in bathroom (general miscommunications from planners to staff that worked event)

DISCUSSION: Debrief on SGA Town Hall good turnout and discussions and difficulties from students were heard, moving forward more engagement prior to and during the event to bring student involvement, brought up engagement on our other campus locations such as flyers and other physical representation for events
