Director Zavala: Last meeting we discussed the parking fee, continuing from there, we will continue discussing parking: there are ways to raise the parking fee if one of two criteria are met, our campus does not meet these criteria. There is also the possibility of reducing the parking fee or exempting low-income students from paying the parking fee if they demonstrate financial need. The money from these fees can be allocated to various areas including parking maintenance, parking staff, the parking meters, security, and Public Safety. Moving on, let continue with transportation fees.

Senator Montero-Garcia: This is the area of the handbook where we can do the most.

Director Zavala: The transportation fee in the handbook states that students and faculty can be required to pay a fee to reduce the fare of common carriers in the public transit system. Only those who utilize the transportation service are required to pay the fee, but the district can charge all employees and students if they decide so or if the majority of employees and students vote by majority to require all students to pay the fee.

Senator Montero-Garcia: This would be a difficult motion to pass, seeing as voter turnout isn't very high.

Director Zavala: Yes, but according to the handbook, for this to pass it only requires 50% majority vote from the total number of voters. The fee may – technically – also be charged to online students. The only obstacle would be calculating the amount each student would have to pay, but I would assume it would only cost 00.50 cents or \$1.00

Senator Montero-Garcia: Could we get this passed this year?

Director Zavala: Very unlikely, because the process of communicating with the GET Bus, agreeing to the deal, holding an election, counting the votes, informing students, and collecting the fees would take some time. However this is a process I think we are willing to undergo if it will help save students money.

Senator Salcido: And when exactly would this fee be collected?

Director Zavala: Registration would be the best time. Continuing forward, low-income students can bypass paying the fee if it proves to be a financial burden, but in all honesty it should not be. If students under the legal age are attending BC then it is the guardian who must pay the fee. Let's continue, the next item in the handbook is the student representation fee, which is currently \$1.00 and is charged to all students on campus. This fee can only be implemented if the number of voters exceeds the previous three student body elections, since the fee goes to the BCSGA funds. Other colleges, like Cerro Coso Community College and Porterville Community College do not have a student representation fee, but according to this they can implement one as long as they've had three student body elections – it is technically a mandatory fee. The fee can also be used to purchase laptops and legislative research. Senator Montero-Garcia, because we are running short on time, could you please relay this information to Senate.

Senator Montero-Garcia: I will share this during Public Comment. The transportation fee and student representation fee and their use in raising our funds. I will also let our sister colleges know about these.
