- Director Handy sought a motion for this grant to be passed
- Roll call vote: 2/2 motion passes
- b. DISCUSSION: BCSGA Student Services Sticker Tracking System
 - Director Griepsma: shed some light on the previous ICC meeting where she informed the ICC representatives of the upcoming roll out of the new tiered sticker system with a focus of the “Get Involved” sticker.
 - o mentioned that the StudOrgs fought it incentivizing to be offered more money for the travel SOF grants and monthly highlights of those StudOrgs that are engaging the student body outside of their normal meeting times.
 - Director Handy: inquired what the logistics may look like for the Universal QR code that he is proposing for campus wide sign-in during events and volunteer opportunities
 - o Director Griepsma: in terms of the StudOrgs, the variables should include: BCSGA hosted events, Volunteer Opportunities (Farmer’s market, pantry, etc.) and students' engagement with other StudOrgs meeting/events
 - o Director Handy: inquired about the safeguards to make sure people are not abusing the system when they attend the LRC options and volunteering options
 - o Director Griepsma: shared that there could be a one-time, randomized code used for each of these events that only can be acquired at the time of the event; this would streamline the back-end processing of attendance and ensure that people are not abusing the system to achieve the new sticker opportunity
