i. If the Director cannot attend, this duty shall fall to the Activities Manager”

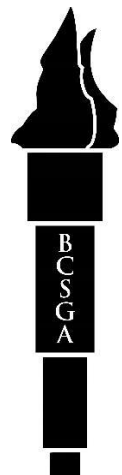
Chair Barraaj proposed striking and amending COBRA 501.05b3 stating,
