1. CALL MEETING TO ORDER

The meeting was called to order by the chair, Director Garcia, at 4:07 p.m.

2. ROLL CALL*

A majority quorum must be established to hold a bonafide meeting

The following members were present: Director Garcia, Senator Salcido, Senator Bernal, and Senator Van Horne.

The following members were absent: None.

The following members were excused: Manager Juarez

4/5 members were present, quorum has been established, and a bonafide meeting can be held.

3. AMENDMENTS TO THE AGENDA

The Senate will consider any amendments to the agenda.

Senator Salcido: In item 6.c. my name is misspelled, it should be, "Salcido" with an "i" not an "e". Also, the date under Item 4.a. should be changed from "8/10/16" to "8/11/16".

Director Garcia: The date at the top of the agenda needs to be changed from, "2015" to "2016".

4. CORRECTIONS TO THE MINUTES

The Senate will discuss and correct minutes from previous meetings.

a. The Senate will consider the approval of unapproved minutes from the meeting held on 8/11/16.

Director Garcia: Under Item 6.a., the second sentence has the word, "WE" in all caps and needs to be, "We". Another one is Item 6.b., DeAndrei's name is misspelled, needs to be changed from, "Deandre" to "DeAndrei". Still under the same item, two sentences before the name change, the word, "time" needs to be added to the sentence after, "if you have some free". Under Item 6.f., in the sentence, "I am excited for all f the events coming this fall", the letter, "f" should be the word, "of". Item 8.a., there needs to be a period after the first sentence, as well as further down in Discussion under Manager Juarez's dialogue, the word, "the" should be, "this". Item 8.c., under Discussion, the second time Manager Juarez speaks he says, "Normally we are supposed to have quotas". The word, "quotas" needs be changed to, "quotes". Again under the same item, following Manager Juarez's dialogue the word, "water bottles" is missing after, "we will be stuffing the,".

Senator Van Horne: Under Item 8.d. where I speak it says, "I agree, since we don't have the budget here with us right now, I don't this this action item is necessary." The word, "this" is repeated twice and I believe it is supposed to say, "I think this".

Director Garcia: This was due to liability issues, as well as holding such a contest would go against both the Pantry's message and yours.

f. BCSGA Advisor, Mrs. Wright

I just wanted to give you all an update on the Welcome Tents we had set up on Monday, Tuesday, and Wednesday. On both Monday and Tuesday we had 4 tents, and on Wednesday we had just one tent, but in total we helped over 3,000 students over those 3 days. We handed out agendas, water bottles and helped students during those first 3 day of the first week.

Discussion

Director Garcia: As you all know for the Meat & Greet we will be using \$300.00 for the supply of the 200 hot dogs.

Advisor Wright: Does this include the both the hotdog and the bun? Will the money also be used for buying condiments, or will the clubs be assisting this event and provide those items?

Director Garcia: I would need to talk with our Secretary Arisve and ask whether or not that will be included, but I will get back to you on that.

Advisor Wright: So, just for clarification, the clubs will no longer be involved with our Meat & Greet event, since they won't be providing and condiments; so students will just be getting their hot dog, whatever topping are available and be on their way?

Director Garcia: yes

Senator Bernal: And where is this being held?

Director Garcia: At the Renegade Crossroads.

Senator Bernal: And will this event be utilizing the KVC Sticker at all?

Director Garcia: We will be selling the hot dogs for \$2.00 without the KVC, but free with the KVC Sticker.

Senator Bernal: Will there be vegetarian or vegan options.

Director Garcia: Unfortunately, we do not have time at this point to implement other options, but I can discuss this further with Arisve.

Senator Van Horne: Were you the one to submit the request forms for the hot dogs? And if so, how exactly did you determine the quantity needed for this event?

Director Garcia: I simply talked with Arisve and, looking at our previous events, we determined that 200 hot dogs would be enough. Originally the price was \$500.00, but after several talks, we were able to drop the price to \$300.00. If there is no further discuss, let us move on to roll call:

Director Garcia: I am seeking a motion to strike out Item 7.c., "Approval of allocation of funds not to exceed \$50 from TA-100 student activities for the purchase of supplies for 'Renegade Pep Rally & Pancake Feed".

Senator Salcido: So moved.

Senator Van Horne: Seconded.

8. NEW BUSINESS

Items listed have not already been discussed once and thus are considered for approval by the Senate.

a. Discussion of Welcome Week turnout.

Discussion:

Senator Van Horne: After our Welcome Week booths Monday, Tuesday and Wednesday we gave out a lot of agendas for the students, but I know we still have a number of them. How do we plan on distributing those remaining planners out to students?

Director Garcia: We also have some water bottles leftover, so we could probably use the remaining items for future events.

Senator Van Horne: But do we have a schedule of some sort with dates on future events or booths?

Director Garcia: At this point, we do not.

Advisor Wright: We've saved planners for new and returning students attending the spring semester who didn't attend the fall. We've also allocated a number of planners to various departments – ASTEP, EOP&S, Veterans, etc.

Senator Van Horne: And how many planners do we have?

Advisor Wright: We order approximately 10,000 total. But just during the Welcome Booths we gave away 3,000. And even after the first 2 weeks, students can still come into the Office of Student life.

Director Garcia: We still have a number of water bottles leftover as well, I believe we will be selling them on a discount next time for those with the KVC card. This first week was mostly to promote the KVC, which I believe was very successful.

Senator Bernal: I strongly believe that hosting these events along with the KVC sticker is a great way to get student involved with future events. Students love to receive free goodies and it's a great incentive for students.

Director Garcia: We have a number of future events planned, all of which will involve the KVC sticker in some way.

b. Discussion of possible items to consider for the rest of Welcome Week.

Discussion:

Senator Salcido: I noticed this week that there was quite a bit of miscommunication throughout the week, especially with volunteers, organizing and setting up booths. I, for instance, was scheduled to set up a booth, but wasn't informed that someone else had done it earlier that day. On top of that, I believe we were supposed to hold a "How to Tie-Dye" day, but I never happened.

Advisor Wright: I addition to what Senator Salcido said, while our events were successful and we served a number of students throughout the week, many students who signed up for certain events never showed up or weren't informed. Maybe for future events we could have an Excel spreadsheet with everyone who signs up so we can contact them before the event.

Director Garcia: I agree that we need to get volunteers who sign up for events to participate in them, we used a system called Sign up Genius, which included staff, faculty and students. Next meeting we can go more in depth on the issue, but thank you for your feedback, it is very important for the success of future events.

c. Discussion of football games/scrimmage

Discussion:

President Frazer. For every football game held here at BC, I will be firing the t-shirt cannon. I don't know who will be helping me during those games, but we can discuss that later on.

Director Garcia: Who do you mean when you say, "someone"?

President Frazer. I just mean that I will have a senator or another officer help me during the game.

Director Garcia: we also need someone to go to the scrimmage on Friday, Dr. Damania sent me an email asking that someone from BCSGA attend that day.

President Frazer. I will not be present for the scrimmage games, but I will be attending the home football games.

Director Garcia: That's fine, I just need two people from who can stay for an hour around 6:00 p.m. to 9:00 p.m., just in case.

Senator Salcido: When did you receive this email from Dr. Damania? Because this is the first I've heard of it

Director Garcia: A few weeks ago. I'll speak with him again just to make sure he still want to go forward with that.

President Frazer. Not many people attend those games, just family of the players.

Senator Bernal: What exactly is scrimmage?

President Frazer. It's when opposing teams from different schools hold practice games, but still has a game feel to it.

Director Garcia: The scrimmage is from 6:00 p.m. to 9:00 p.m. on Friday, if anyone wishes to go please let me know so I can write down that you attended. And President Frazer, if you get any response form Dr. Damania before adjournment, please let us know in public comment. Next week we will have more information on upcoming games.

President Frazer: The next game that I know of is on Saturday, September 10th, the gates open at 6:00 p.m. and kick-off starts I believe at 7:00 p.m. I recommend that all SGA able to attend come support our team.

Senator Bernal: I have two things: first, we should hold a poster party on campus in support of our team. And second, what will SGA be doing at the game? Are we supporting, holding a booth?

President Frazer. We are just attending to show support for our football program.

Director Garcia: In addition, Student Activities will be assisting President Frazer with the cannon, as well as hosting the club competition with Director Smith. The winner of the competition receives a gift card of \$100.

Senator Salcido: It's a wonderful incentive for club participation, so I highly recommend clubs participate. It is also a great way to further promote our KVC sticker, which allows student to receive 2 free football tickets.

President Frazer. Quickly, Dr. Damania just got back to me and says that we can attend the scrimmage if we want.

Director Garcia: Since we don't have the numbers to attend that game we won't be sending anyone to the scrimmage.

Advisor Wright: Also remember to wear your BCSGA polo, not your WE ARE BC t-shirt to the football game that will separate you from the rest of the student and let them know who you are.

Director Garcia: And remember, we still have a week of events to go, so don't relax just yet. Remember to sign up, attend events and promote the Movie Night. Since it is our time doing this event, we want It to be as successful as possible.

Senator Salcido: May I contact Porterville and Cerro Coso and invite them to our Movie Night?

Director Garcia: Please do.

Advisor Wright: We should make flyer with the movie night dates so we don't have to reprint more later on.

President Frazer. And let everyone know that this is a free event.
