CALL MEETING TO ORDER*

The meeting was called to order by Director Hidalgo at 11:15 a.m.

ROLL CALL*

A two-thirds quorum must be established to hold a bonafide meeting

2/3 quorum was established, thus a bonafide meeting was able to be held.

Discussion: A point of clarification was made about the agenda being posted prior to resignation of Senator Maner and in being recognized by the BCSGA Senate Body. As such, in the same meeting, Daron Smith had been appointed as a Senator, and thus replaced the empty spot on the Department board.

Chair, Director of Student Organizations, Director Chad Hidalgo: The "shoes" are ready for clubs to take and to sell. The goal that ICC is trying to meet overall is \$500, and to qualify for a pizza party by reaching this goal. For the club that raises the most funds, they will win a pizza party and \$100 SOF grant. Second place will win \$100 SOF grant, and third place will win a \$50 SOF grant. The "shoes" come in various colors which represent different denominations. Red is \$1, blue is \$5, yellow is \$10, and green in \$20. The OSL production team is working on making a banner to publicize about it, and donations to this cause or for the shoes are not limited to only BC. This is open for all. - b. BCSGA Advisor, *Dr. Damania:* The pantry program is transitioning to a student assistance program, where hygiene, housing, clothing, and food assistance can be provided. Fresh fruits and vegetables are being handed on certain days. There is daily bread Monday through Thursday. The pantry will now be doing a farmer's market the first Wednesday of every month. Gleaners is helping with fresh fruits and veggies. The Renegade Pantry is fully self-sufficient by donation. There are new travel forms that are to be filled out as well as protocols for how to finish/submit them. Bakersfield College also now has a mobile app! The mobile app is called BCRenegades. For any clubs that would like to have mobile app presence, please let me know. We will also try to get you a Facebook page or a link to yours if your club already has one. If you have a website, or a twitter, please also let me know. A reminder is that Amber Chiang, myself, and your advisor need to added as administrators on the account. If your meeting times are not correct on the BC website, or the links or people listed as officers are wrong, then let me know immediately and provide me the correct information to correct it! The current information listed is what will be placed on the app, and we will be doing a run through to have everyone update any old information for their club. Additionally, if you see a form or something that you feel needs to be included in the app, then please also let me know.

b. It was moved by Manager Scott and seconded by Senator Smith to approve ACTION ITEM: move the amount of \$600 from uncommitted funds to support the presentation of Lorenzo Cuesta, Registered Parliamentarian (joint project with Department of Judicial Affairs)

Discussion: It was discussed that Lorenzo Cuesta, who is the Registered Parliamentarian that spoke at SSCCC, will be coming down to Bakersfield College to give a presentation to all clubs, students, and to invited student governments that are within Region V and also nearby colleges. The event is proposed for April 22nd from 1 to 4 p.m. The departmental board and ICC body weighed the pros and cons of the allocation. The con primarily shown was that there would not be enough people committed to attending, and whether or not it would prove to be useful or effective for members since it is geared towards the end of the year. The pros were that all of Region V is invited, faculty, Cerro Coso, Taft College, Porterville College, and the public is also invited to attend. Moreover, there is a Region V meeting that is to be held on the same day, so it could entice the people to attend, and that this could be a workshop to help new and incoming officers.

- a. Director Hidalgo: ICC has the power to introduce bills and resolutions to the Senate in order to make the ICC meetings mandatory, or to send a delegate for those clubs whose ICC representatives that are not showing, as well as to have repercussions in failing to do so. But that means that you must have quorum, which is the majority of 36 registered clubs, otherwise you cannot send it to the Senate. The alternative is to implore a Senator to sponsor a bill on your behalf in order for that to happen. I am doing what I can to reach out to all clubs. A listserve is being created for all ICC members. I have handed out the Renegade Pulse which has all of the current events for next week. Please submit a publicity form to be included on the Pulse. The Bakersfield Blaze is also giving us fundraising opportunities. So you essentially pick any future game to fundraise for, sell tickets, and your club receives half of those proceeds.
- b. Student-at-Large Hawks: I recognize that we do not want to be adding more stuff to our plate as students, as club members, and also as representatives for this body. However, it is not serving the rest of us, who are actively engaging in the rest of the government and taking this information back to our clubs, well. As such, I am looking to see what it is that the ICC members present here today, and for those who are active within the campus, are willing or wanting to accomplish, and what we will do to reach that.
