b. Senator Lawrence Salcido



d. BCSGA Advisor, Dr. Damania

7. UNFINISHED BUSINESS

Items listed have already been discussed once and thus are considered for approval by the Senate

 Discussion and approval of the BCSGA StudOrg Conditions and Procedures Discussion:

Senator Salcido: The numbering on the current page is not in order.

Dr. Damania: That will be changed.

Director Smith: Hello P.T.K, I want to clarify that your document is a little different from the one we are viewing. The only difference is that we have a simpler version of the document, wheareas you may have a version that is not as simple as ours. All of the changes are still the same though.

Senator Salcido: Under subtle hazing, "Neglecting new members," does that include if the constitution of the club requires you to have certain things? For example, if you were required to be a veteran to join the Veterans Club? That is not the case, but I am just curious.

President Frazer: I think it is more of leaving someone out of events and activities that the club is doing as a whole. That would be considered neglect of the new members.

P.T.K: Under online registration, does fiscal year really have to be specified again with, "FY?" Don't you just need to cut out, "FY17," since this document will be used in the following years?

Director Smith: Thank you very much.

Senator Salcido: Item number 13 says, "The following information for the President, Treasurer, ICC representative, and advisor," we no longer need the BC, "@," number for the advisor.

Senator Salido: This is more of an announcement. Last semester this document said that ICC representatives should attend ICC meetings. We changed, "should," to, "must," with the bill that Director Smith presented when he was a senator. So, now it is mandatory for ICC representatives to attend meetings or to have excused absences if they cannot.

Senator Salcido: Under, "Organization and Responsibility Matters," item number one. "ICC representatives should," must be changed to, "ICC representatives must," for consistency in the language.

Director Smith: I will send these corrections to Dr. Damania.

b. Discussion and approval of the BCSGA StudOrg Funding Grant Process Discussion:

Pre-law Club: There needs to be a consistency in the capitalization of the word, "department," throughout the document.

In there being no further discussion, the chair sought approval of the document.

The document was approved due to a unanimous vote of, "ayes."

c. Discussion for Student at Large members appointments by BCSGA Advisor Discussion:

Director Smith: We need a, "Student at Large member." That is one person out of all the ICC representatives that is selected to carry out the vote of the rest of you. They have voting power at ICC meetings the way senators do. Can you clarify more Dr. Damania?

Dr. Damania: The Student at Large last year was Patrick Hawks. It is a person that sits on this department itself, not on senate, and is appointed by myself to represent the larger body.

Senator Salcido: It is an ICC representative to represent the rest of the ICC representatives. The person in this position would be given a vote and is responsible for voting in favor of the ICC representatives as a whole.

Director Smith: One person I would like to recommend for this position is Dyann Serrato from the Pre-law Club. She always listens to both sides of the story. I feel she would be a good candidate for the job. Are there any other nominations? Seeing none, we will move on.

8. NEW BUSINESS

Items listed have not already been discussed once and thus are considered for approval by the Senate.

a. Halloween ball committee

Discussion:

Director Smith: This committee has been started by Director of Activities Garcia, and myself. We would like to get clubs involved because this is where the more serious stuff for the event will take place. That would include setup, cleanup, and probably the building of a few props. I ask that you take this information back to your clubs and see if anyone wants to volunteer.

Nursing: Do you have set dates or set days of the week for the Halloween Ball committee?

Director Smith: I do not yet because the committee is barely getting off the ground. Once we have the information, we can e-mail those to everybody.

Senator Salcido: What we did last semester, we had a committee for Extra Life and one for the Condors Teddy Bear Toss. The meetings were held on off weeks from ICC meetings, so we would meet on the second and fourth Fridays of the month. We might do that again, but it is not a guarantee. For reference, that is just something that we did last semester.

Director Smith: I can talk to Director of Student Activities Garcia, and come back to settle on the dates here because there is a lot of club involvement.

Intervarsity Club: The date for the Halloween Ball itself, in your previous minutes, you have the date listed as, "August 28, 2016," which is not the Friday before Halloween.

Director Smith: Thank you for bringing that to our attention Intervarsity Club. That is our mistake. The official date is October 28, 2016. Sorry for the confusion.

Tutoring club: We will definitely be joining. If not multiple members, then I will be joining myself.

b. Public Speaking workshop

Discussion:

Director Smith: Here is a full list of upcoming workshops for the year. The times for the fall and spring semester have not been decided yet due to class scheduling issues. As soon as the timing issue is resolved, everything will be updated on the website. The public speaking workshop will take place on July 7, 2016 in here from 12:30 p.m. - 2:30 p.m. I would highly suggest coming.

Senator Salcido: I see you have three dates listed for public speaking. The 7th, 21st, and the 28th of July. What are the purposes for that?

Director Smith: The purposes for multiple public speaking workshops is that, in my experience, you cannot learn to speak publicly effectively within one session. This is more of a training. We will be getting students and anyone in ICC to have a hands on approach. We will be working on exercises. One of them is the filler drill. They stand at the front of the room and present on a random topic. If they use any filler like , "uhm," or , "ah," then we add more time to the duration they have to speak. That really engages the person to think and talk without using fillers.

c. Club Participation bill: drafting

Discussion:

We will not be drafting a new bill. We will be amending the one that was passed recently. It is under section 10 of COBRA, on page 52. We will change what Senator Salcido mentioned earlier. So far the entire section that concerns the ICC was changed to incorporate the discussed tier system which will be amended to include the participation, not just the ICC representative absence. If that makes sense.

President Frazer: Shouldn't it be unexcused absences, not just absences?

Director Smith: Thank you. We discussed that being a part of two events per semester as being the bare minimum.

Senator Salcido: Do they have to be BCSGA events?

Director Smith: No, they can be any events. Do we want to label is as a finite section for the clubs?

Senator Salcido: We should keep it broad, because it is the first running of it.

P.T.K: I would like to confirm that the two events for clubs are school events?

Senator Salcido: So a fundraiser would count?

Director Smith: Yes. Events like Welcome back week, Extra Life, Garden Fest all count. Things like that.

Agriculture club: You said the two events we had to do are any of them on campus?

Director Smith: Yes. Any two public event on campus, per semester. Any more discussion? Senator Salcido and I will get to work amending this section of COBRA.
