

We help promote Student Life and Student Life events here on campus. I am also the Activities Manager working with Director Garcia. Every semester we have wonderful activities for students. Through the Office of Student Life, we offer the newsletter Renegade Pulse. Last semester it was issued in legal size paper. This semester we bumped it up because we have a lot of events going on. I am here today to hand these out to you. This will help boost student involvement on campus.

Senator Salcido: Where can we pick these up.

Manager Juarez: These are accessible on the Bakersfield College website as a pdf. You can print them out from there. I am sure that we will have a nice little stack in the office as well. It is on the website. It would be under newsletter. You could also type, "Renegade Pulse," into the search bar. It might pop up faster. These are weekly newsletters, so a new issue comes out every other week. As registered organizations, you do have a lot of resources available to you here in the Office of Student Life. We have a giant poly that prints banners. They print up to the size of the banner that I have displayed. Every semester, registered organizations get one free banner print. I suggest you create a generic banner that you can re-use, maybe even have it laminated. After that, you are charged a fee. Luckily for organizations, it is a discounted fee. You also get free flyers if you sign up using an order form. We provide a lot of graphics to help publicize you at events. We also include you in the newsletter. The more you register before your event, the more publicity you can gain through us. How much you get charged depends on the size of your flyer.

# a. Workshop dates and locations

# Discussion:

M.E.CH.A Club: I think Get Your StudOrg on was a hit. It was great. It was well put together. I enjoyed being out there with the rest of the student organizations.

Director Garcia: I also want to mention the Les Shwab tire run we want to have during the football games here at the college. Participants compete against one another by rolling an inflatable tire down the football field. The winner will receive a gift certificate valued at \$150 which can be used at Les Shwab Tires. We do not know if Second place will be receiving a prize as done in the past, we will have to check with Dr. Damania on that. We will start that on September 10, 2016. At our next ICC meeting, we will need two clubs to participate in this event. Director Smith should email you all with more information about signing up, where to meet, and other information.

Student At Large Mireles: This is a suggestion for the clubs. If you receive the prize, you could also do an opportunity draw for the gift certificate.

Ms. Wright: That has been done in the past as a form of fundraising for clubs.

Senator Salcido: September 10, 2016 is the date for our first football game. We would really appreciate it if your clubs can come out and show support for our football team. The way it was done last year was that if you participate in the Les Shwab Tire run, you would be given free tickets for representing your club. I am not sure if that is the way things will be done at this upcoming game. It is something we would have to follow up with Dr. Damania on.

Ms. Wright: If you have your KVC Sticker, you get (2) free football tickets already. You can pick them at business services.

Director Smith: We will be trying to have daily table events. I highly suggest that clubs sign up to volunteer once the opportunity becomes available. We will be giving candy out at these tables. These would also count as club participation. This week, we did not have as many volunteers as we needed. We got by with SGA Officers out at each event, but it was very hectic. Things did go well, but they can go better with the more volunteers we have.

Student at Large Mireles: As of what date will club participation be tracked? Are we going by the start of semester?

Director Smith: If you participated in the Student Involvement festival, I am counting participation starting from there forward.

Club: How many required volunteer hours are we supposed to do?

Director Smith: There isn't a limit on the amount of hours you can volunteer. It is more along the lines of just participating (2) members per event, (2) events per semester. What we do ask is that you participate at one of the main events, such as the Halloween ball on October 10, 2016. That is the Saturday before Halloween.

Student at Large Mireles: Is the Les Shwab Tire run included in that?

Director Smith: Yes. Any event held here on campus is fair game.

Pantry Coordinator: There has been an issue with signing up for distributions from the pantry. The dates are for September 8, 2016, and September 29, 2016. The system would not let individuals register for the 8<sup>th</sup> of September. It would automatically register individuals for the 29<sup>th</sup>. We will be switching the affected individuals back to the 8<sup>th</sup> of September manually. I am the pantry coordinator. M.E.CH.A Club: I was made aware that there might be something in the works for, "Dia de Los Muertos," (Day of the dead), for the first week of November.

Director Smith: Yes, there is a Day of the Dead event scheduled to be from October 31, 2016 to November 3, 2016. So it will span from Monday through Thursday. We are currently talking to the President of M.E.CH.A club concerning what events we might have and our participation in them. I would also like to go over decorum. There isn't an issue of how we speak publicly to one another during these meetings. However, there is an issue with timing. If discussion breaks out during a time when it is not supposed to, or the floor is not open for discussion, I will be using the gavel and ringing in for decorum asking for all conversations to cease until the proper motions are set in place. I also ask that you send me or Director Garcia an email if you are planning on volunteering for any event,. This will help me recognize you for participating at an event when I go out to verify that you are present. If you do not take this step, I will thank you for volunteering your time, but your club participation for that day will not be recognized. I need two forms of confirmation. The first would be your email. The second would be me actually seeing you there at the event.

A.S.L. Club: Some of our members would like to help by volunteering at events. How would we go about getting an interpreter for them?

Director Smith: Due to this week being hectic, I ask that if you are planning on signing up to volunteer at an event, that you notify me at least (5) days in advance. We did allow it this week, we will no longer allow it anymore. There were some who registered the day of, or the day before. It did not work very well. We want to work towards having a more efficient process. Unless I say the period to volunteer has been extended, I will no longer be accepting the sign ups who go past the five day in advance period.
