I object to being dragged through this kind of process. Is this the best we can do? I want the opportunity to engage in the discussion, to shape the dialog, and not declaim at meetings.

Again, I am not representing my school because we are still examining documents and deliberating.

I do speak as a practitioner out in the field, invested in the good work the colleges are doing. Somehow entities like the BOG, the Commission, and the Chancellor's Office seemed to have forgotten about the rest of us.
