Christian reported on the Governor's proposed budget changes the formula for payment to colleges from being based 100% on enrollment, to 50% based on enrollment, 25% based on percentage of PELL and BOG recipients served, and 25% on the number of degrees and certificates awarded. Our efforts to improve student success should be rewarded in the new formula. She made two suggestions for follow-up:

- declaring two degrees, how that affects the funding formula, and how we promote that, possibly with the mapper project
- if transfer ready is counted as part of the funding formula

Christian publicly thanked FCCD for their hard work adding additional sections to serve more students. Christian suggested that we all review the CCCCO State of the system report. (available on College Council Website).
