Historical Data and Growth in Transfer Enrollment


#### **ENROLLMENT HISTORY**

Bakersfield College has had a presence serving southwest students for many years offering courses at different locations including Stockdale High School and Bakersfield Christian High School before the current location subleased by Fresno Pacific University. BC began the sublease at the current FPU location in March 2015 and began offering courses in Summer 2015 with 3 sections. As the college experienced growing demand and long waitlists, we explored ways to expand our existing night section offerings in the southwest to include a robust day schedule. Thus, KCCD entered into a 20 month sublease with FPU effective August 1, 2017.

### TRANSFER PATHWAY GROWTH

Increased degree completion has been a high priority for Bakersfield College over the last six years. Since the passage of Senate Bill 1440 legislating Associate Degrees for Transfer (ADT), Bakersfield College has developed and offers 30 ADT pathways. Subsequently, faculty and staff from BC and CSUB collaborated to develop the Kern Promise's *Finish in 4*. This program supports the increase in student completion with an Associate Degree for Transfer in 60 semester units at BC. Students are then guaranteed admission to CSUB, in a similar major, and will complete an additional 60 semester units to earn a bachelor's degree! The *Finish in 4* efforts aim to guarantee students complete their transfer degree in 2 years at Bakersfield College and a baccalaureate degree in the following 2 years at CSUB. Together, the goal is to move students through to the next stage of their educational and career goals in a more efficient and impactful way. Since the inception of ADT offerings at the college, the number of ADT completers has grown significantly, reaching a record of 798 ADTs awarded in 2017-18. And roughly 80% of these students transferred to CSUB.



In addition, the college has intentionally created certificates of achievement for transfer general education coursework patterns to provide achievable momentum points for students to incentivize them to progress towards completion. The creation of these certificates have streamlined the articulation of courses to the transfer institution.

Our Guided Pathways mindset encompasses much of the work described above and has served as the impetus to increase student completion. The main goal of Guided Pathways is to make the pathways clearer, giving students the tools to make the right choices that fit their interests, and being intentionally intrusive in our guidance. This includes the development of accurate and detailed educational plans, building student support services, creating C-ID and Transfer degree curriculum, reviewing our instructional program pathways for clarity, and implementing a strategic outreach and intake program.

The agreement allows Bakersfield College to use FPU facilities for the delivery of college courses and student services in southwest Bakersfield. The term is from **August 1, 2017 through March 31, 2019.** The cost to the District is not to exceed \$448,600.00 annually, to be paid from GU001 unrestricted fund.
