- Coursedog transition from eLumen
 - To facilitate a smoother data migration to Coursedog, we are implementing a temporary freeze on any new course/program revisions and creations.
 - All courses/programs that have reached Stage 4 by the end of the fall 2025 semester will remain in the eLumen dashboard with the goal of being completed through the spring 2026 semester. All other courses/programs, including those not completed during the spring 2026 semester, will need to be redone once the implementation of Coursedog is complete.
 - We recommend keeping a copy of any work done in eLumen by downloading a PDF.
