#### II. Reports

- A. Curriculum Status Update
  - 1. Curriculum Push for Accreditation

Billie Jo Rice reported that the Curriculum Push on October 9, 2012 resulted in two hundred and forty pieces of curriculum being reviewed. She also reported that the President sent an email to the Deans that courses out of compliance would have to be in the CurricUNet queue by October 26, 2012 or they would not be offered in Spring 2013. Nick asked how a "good faith effort" would be determined. Billie Jo responded that just copying courses in CurricUNet was not a good faith effort.

2. Out-of-Course Compliance Course Deadline – 10/26

Billie Jo reported that originators of courses from the September 20<sup>th</sup> agenda were notified that changes needed to be made to their courses and were asked to make the necessary changes by October 15. For those courses, where the originator did not make the requested changes the courses will be removed from the approval queue on Saturday. The work on the courses will not be lost; the courses will only revert to the originators queue. Once the originator has addressed the necessary changes, the courses can be resubmitted and the approval process will start all over again.
