I. Called to Order

A. Curriculum Status Update

- 1. Billie Jo expressed appreciation for a great job done this year. There were a lot of obstacles overcome: two new co-chairs, new curriculum tech, accreditation task force, problems with CurricUNET, etc. There are 951 courses on the books and the committee processed 371 this year.
- 2. The back of the agenda contains the year-end report for the Academic Senate. It was reviewed. The following suggested changes will be added to the report: to recommend an increase in classified staff to help with the curriculum, numbers comparison from last year (371 this year vs 137 last year), mention the problems in CurricUNET, how much time per course it takes to go through the process, and the length of time to implement a course.
- 3. Content Review Guidelines Task Force Update
 Billie Jo stated that next year we will have new guidelines in place.
- 4. Skills Prerequisite Task Force Update

Kimberley Van Horne stated that the task force is in an investigatory state to determine what they need to accomplish. Dawn Dobie stated that Janet Fulks suggested focusing

on reading and writing first. They are discussing adding reading and writing first as corequisites in English and Reading courses. They are trying to have something by late fall. Timeline for implementing revised courses needs to be looked at so the registration problems we have been having do not happen again. Sharon Bush stated that you need to be mindful of the capabilities of Banner. Banner will not allow certain course coding with regards to prerequisites and corequisites.

B. Articulation Officer

1. Sue Granger-Dickson stated that it would be beneficial to have a summer internet vote for some of the programs. Billie Jo said that it would not matter because Sharon is not here during the summer, so no one can submit it to the state. The degrees need to be entered in CurricUNET and go through the program review process. The committee needs training to review programs.
