- 2. CID ART B35 & B36; CHEM B2A, B11, 1A, 1B; ENGL B30B; MATH B6b, B6d; THEA B14 received either CID conditional approval or were not approved. These courses need to be revised in order to be approved for CID. If these courses are part of an ADT, they must be CID approved by December 31<sup>st</sup> or the State will inactivate the ADT. Colleges are not allowed to go back to offering their AA/AS "local" degree if their ADT is deactivated. Please get the revisions in CurricUNET as soon as possible because they must be approved by the curriculum committee and the Board of Trustees before being submitted to CID.
- 3. Program Review —Please emphasize to your departments that the courses due for review need to be approved through the curriculum process in order to be "active" in CurricUNET.

CurricUNET Training - The orange handout was presented as a slide show presentation.

To revise a course: Do a course search of your discipline; the red courses are active courses; scroll over reports from an active course; click on copy course.

Some key things to remember about CurricUNET: Always use Firefox or Chrome.

Under Basic Course Information:

Catalog Course Description - List any notes for the catalog as the last sentence that you want to appear in the college catalog.

Proposal Information – check all the boxes that apply to your course changes. If the course does not have IGETC or CSU GE and you want to request it, check the box and specifically state the areas you are requesting. Do not check the box if the course is already approved for CSU GE or IGETC.

- -make sure to state every change you are making to the COR and give a reason for the change in the summary box.
- -standard language for revision rationale: Six year revision to keep the course content current.

Proposed Start – use the curriculum calendar for the correct semester/year.

### **Under Program Applicability:**

Core Mission – check all the boxes that apply. If CTE make sure to check the CTE box to open up the Scan Competencies menu item.

Local Program – check the programs in the catalog and mark all that apply.

Under General Education/Transfer Applicability:

BC GE, CSU GE, and IGETC – only check the areas that the course has already been approved for (i.e. current status).

**Under Student Learning Outcomes:** 

List each SLO separately. List the Course objectives too.

**Under Conditions of Enrollment:** 

Content review can be uploaded on the page now.

Make sure to include the updated content review forms.

For reading meet with Academic Development; Writing meet with English; Math

meet with Math.

Any changes need to be stated under Basic Course Information, proposal information (including the change from reading level 5 or 6 to reading 1 level prior to transfer).

**Under Scan Competencies: ONLY FOR CTE COURSES** 

You must check the box under program applicability for the menu to open.

Make sure to check every section.

**Under Topical Outline:** 

Enter each outline point separately.

Please use standard formatting (I.A.).

**Under Course Methods of Instruction** 

Check anything that applies. Be careful not to the methods to a small list because different instructors use different methods.

Under Out-of-Class assignments:

Provide a brief description of homework assignments.

Under Texts, Readings, and materials:

Textbooks should be dated within the last five years. Some courses need a State publication or periodical that is older than five years. If older than five years, provide a justification for the outdated text.

Under Delivery Method of Instruction:

For Distance Ed show sustentative contact between the student and teacher, student and other students, student and material. Stating that the teacher and student email each other is not enough.
