# GE and Transfer Guidelines

CSU Transferability was delegated to CCC by CSU Executive Order 167

UC Transferability is reviewed externally

UC TCA required for IGETC consideration

UCs requires textbooks to be published within seven year of review

Cal-GETC Area 7 (Ethnic Studies) submissions starting this cycle

Cal-GETC are reviewed externally

- Effective the following Fall
  - No Appeals
  - Two-level Independent Review
  - Governed by the GE Guiding Notes

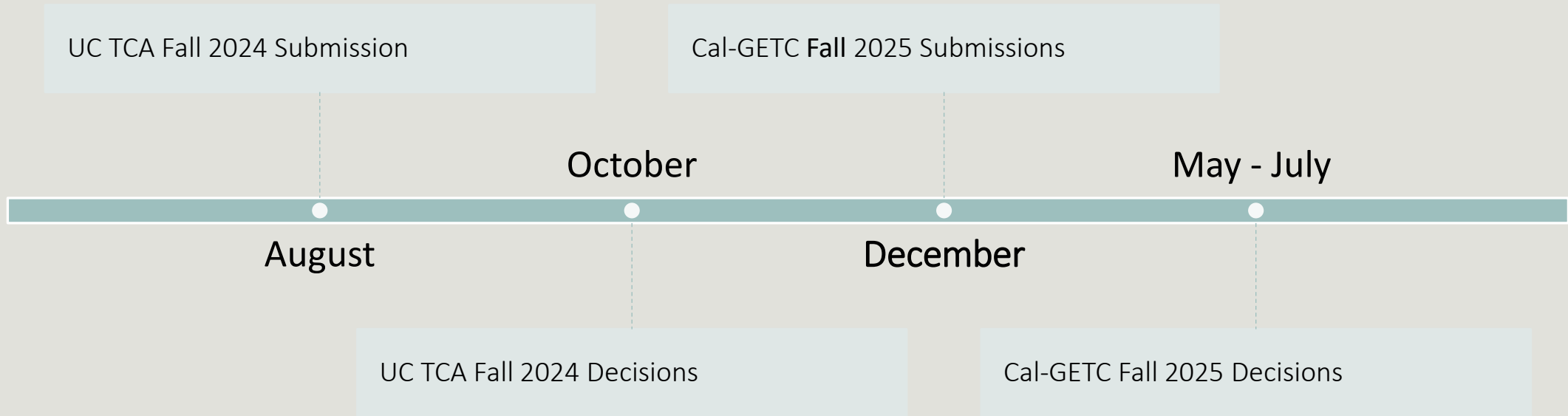
## Fall 2025 Implementation

- Establishes singular pathway for CSU & UC
- Impact on BC courses
  - Removes Area E
  - All GE must now meet UC standards
    - e.g. applied vs theory
- Some areas will need to be re-reviewed
  - Not all courses will keep their transfer GE status
- AB 928 Task Forces
  - State
  - Local
