AB 928 Updates

CCCCO held a webinar on 2/28/24 at 10 am providing clarification on the <u>Cal-GETC</u> <u>Administrative Implementation Guidance Memo.</u> More information, as well as the recording and powerpoint, can be found at <u>ccctransfer.org/cal-getc</u>.

Notes from Q&A

- Oral Communication will not be part of the 7-course pattern to transfer to a UC.
- Cal-GETC for STEM is still an unresolved issue.
- CSU Board of Governors will finalize decisions regarding Life-Learning and other non-Cal-GETC areas this semester.
- UCs do not have system-wide catalog rights approach.
- Language Other Than English (LOTE) will become a graduation requirements at the UCs. More information coming from the system.
- All courses being submitted for Cal-GETC must be UC-TCA approved.
- Currently no recency requirement on ADT degree conferral or full GE certification.
- Cal-GETC review will go through the same review process as IGETC each course has multiple reviewers.
- The next version of Cal-GETC standards is estimated to be reviewed by ICAS in May 2024.

Cal-GETC Implementation on the ASSIST Platform

- All areas from IGETC will migrate to Cal-GETC except for Area 1C Oral Communication. College will submit those separately in December 2024.
- Updates need to occur in ASSIST: Database, Workflow, Curriculum, Articulation, Report, Data Sharing, Resource Center, Public Site
- ASSIST Implementation Plan and Timeline
 - <u>Phase 1 (Summer 2024)</u> Database and Curriculum area updates, IGETC to Cal-GETC data migration project
 - <u>Phase 2 (Fall 2024)</u> Workflow area system updates ahead of course submission and review cycle, Data sharing updates, Reports are system updates
 - <u>Phase 3 (Winter 2024 Spring 2025)</u> Support of 1st Cal-GETC reviewcycle (CCC course submissions, system office reviews) and additional system improvements, Articulation area system updates
 - <u>Public Go-Live (Summer 2025)</u> Public site updates with 2025-26 Cal-GETC searchable lists

Catalog Rights and General Education Certification

Who does not need to follow Cal-GETC?

Continuous enrollment prior to Fall 2025 can follow CSU GE Breadth or IGETC.

- May elect catalog rights for non-major requirements.
- Attendance in regular terms.

Students with official transcripts who earned ADT or full certification of CSU GE or IGETC.

Cal-GETC Certification applies to:

- New students beginning Fall 2025 or after
- Noncontinuous enrollment
- High School graduates who start at a community college Fall 2025 or after
- Students with catalog rights prior to Fall 2025 who elect to follow Cal-GETC
- No partial certification for CSU or UC transfer


AB 1111 Updates
