AB 1111 (Common Course Numbering) Update

From ASCCC President Cheryl Aschenbach's message: "As part of the timeline recommended by the CCN Task Force and then augmented by the CCN Steering Committee and CCC Chancellor's Office, the ASCCC is being asked to convene discipline faculty in **Communication Studies, English, Math, Political Science, and Psychology** to draft CCN descriptors for the 6 highest-enrolled general education courses, identified below:

- College Composition (C-ID ENGL 100)
- Argumentative Writing and Critical Thinking (C-ID ENGL 105)
- Public Speaking (C-ID COMM 110)
- Introduction to Statistics (C-ID MATH 110)
- Introduction to American Government and Politics (C-ID POLS 110)
- Introductory Psychology (C-ID PSY 110)

The CCC Chancellor's Office determined August 15, 2024 as the date by which CCN descriptors for the initial 6 courses shall be finalized to meet their proposed timeline. Because of this, the ASCCC will be convening intersegmental discipline meetings on June 12, June 18, and June 24.
