End Of Year AO Reports

The End of Year reports for the 2024-25 academic year for both courses and programs is available. These lists explain the curricular changes approved by the Curriculum Committee during the 2024-25 academic year.

AB 928 / Cal-GETC Updates

A new Standards, Policies, and Procedures Manual was approved in May of 2025 – [Cal-GETC Standards 1.3](#). As a reminder, use the [Guiding Notes for Cal-GETC Course Review](#) if you or your department is planning on creating or revising a course and seeking Cal-GETC approval.

AB 1111 (Common Course Numbering) Updates

Phase I courses and impacted ADTs are all revised. Courses that list Phase I courses as a requisite need local revision.

Phase II Part A courses need to be student-facing by Fall 2026. This gives them an October 9th Curriculum Committee 2nd read deadline. They need to be submitted for Board of Trustees approval in November, Cal-GETC review in December, and UC TCA review in August to make the Fall 2026 deadline.

Phase II Part B and Phase III courses need to be student-facing by Fall 2027. This gives them an April 30th Curriculum Committee 2nd read deadline. They need to be submitted for UC TCA review in August 2026 and Cal-GETC review in December 2026 to make the Fall 2026 deadline. Please note, the Phase III templates are not released yet.
