- C.Jones: Confusion with the "active shooter" terminology; Maybe make more clear in the narrative what is happening
- R.Barron: Would be nice to have College Safety barricade parking areas immediately so that we
 mitigate people from the public entering campus
- R.Barron: Suggestion to send ShoreTel alert for emergency situations
- R.Barron: Using red, yellow, and green light system in CDC to let staff know how to handle children during certain situations
- K.Ford: Possibly using PA system to notify people of lockdown
- K.Ford: Several students heard the gunshots because they were very nearby; think that calling it an "active shooter" situation was appropriate given proximity
